**Please read the following instruction carefully before filling the application form**

1. The application has to be filled in BLOCK letters
2. Mention your name's spellings as of your official name. Based on these spellings, you will be issued training certificate. Institute is not responsible for any mistake in spellings.
3. Clearly mention if you are applying at your own or on behalf of any organization.
4. In case you are applying on behalf of your organization and organization is paying your training fee, signatures from your relevant nominating authority will also be required.
5. Please make sure that you are enclosing demand draft in favour of '**Solve Agri Pak (Private) Limited**'. No application will be considered without payment.
6. The early bid registration fee will be at 10% discount. The rates are applicable only for those applications, which will be received on or before deadline of early bid registration i.e. 1<sup>st</sup> of July 2017. Any application received after this date, will not be accepted with the discounted rates. 10 % discount will be applicable for group registration i.e. 4 or more than 4 registrations from one organization.
7. In case, your application is accepted, the institute will send you the confirmation within 3 working day (by email). The confirmation email will contain your registration number (which will be your reference for future communication with the institute) along with the detailed schedule of the training and other necessary details.
8. SADI will only provide working meals (lunch and teas) at institute. You will have to make your own arrangements for accommodation, non-working meals and transportation to the institute and back.
9. 100 % attendance is required during the training hours.
10. At the end of the training, each participant will have to prepare and present his/her Back Home Action Plan (BHAP).
11. In order to ensure effective training, the institute has limited number of seats, which will be filled on first come first get basis. In case, your application is received and no seats are available, either the institute can hold your application in the waiting list and you will be automatically considered in the next training or your payment can be returned to you without any deduction. In such scenario, institute will contact you and ask for your preference among both the options.
12. Please note that, if your application is accepted and you are issued a confirmation letter along with registration number, your paid fee will be non-refundable.
